AS BENEFICIARY ACTING SOLELY AS NOMINEE FOR HIGHLANDS RESIDENTIAL MORTGAGE, LTD., ITS SUCCESSORS AND ASSIGNS; (2) all renewals and extensions of the note; and (3) any and all present and future indebtedness of BRADLEY BURGESS, A SINGLE MAN to BRADLEY BURGESS. 
